Cal received an alert call (Alert Electronics) last week and he responded and there may have been an electrical outage and it was corrected. The lead acid batteries that take over when there is electricity goes out were needing replacement. The guys from Marquette gave Cal a run through on how the alert monitoring system operates. There are sensors in various locations that sense if there is smoke or fire, etc. Three or four

years ago the sensor on the south side coming up the entry steps had a valve on it that let off steam. Cal had that one deadheaded and that stopped the false alarms. The batteries were replaced and the system is up and running.


11. Old Business
